When the vote was taken on my ordinance, all seven councilmen then present voted "aye". We have to face the fact that we are a minority party in St. Charles County. I know what it takes to win under these conditions.

For those who I have not met previously I want to mention that from 1951 until 1963 our home was at Augusta in Femme Osage Township. During most of those years my wife Jean was a committeewoman from that township. Those who were on the committee during the Eisenhower terms will remember the Republican rallys with the German band we held in the wine cellars at our home and the crowds of near 500 persons who would attend.

When the vote is taken to elect a chairman and vice-chairman, I ask your vote for chairman of the St. Charles County Republican Committee and your vote for Miss Billie Meers as vice-chairman.
