

## Only One Of Incumbents Is Re-Elected

St. Charles voters returned only one opposed incumbent candidate to the city council in city elections yesterday and as a result there will be four new faces on the council when it convenes on April 19.

Light voting marked all the elections as a total of 2419 voters out of 11,533 registered voters in the city exercised their privilege. In the voting, two incumbents were defeated in their bid for reelection.

William Baggerman beat Second Ward Incumbent Councilman Irva Richardson by the surprising plurality of 373 to 203. In the Fifth Ward, incumbent Bill Mc-Clintock drew only 88 votes as George Sturmon piled up 231 votes to win the race. Wayne Pallardy finished with 34 votes.

In the wide open race for the one year unexpired term in the First Ward, the Reverend Robert W. Magee garnered 290 votes to win in the crowded field of seven candidates.

Harold A. Webbink finished a strong second in the race with 238 votes and Robert C. Buehler collected a total or 204 votes. Other totals in the contest were: Fred S. Creacy, Jr. 94; Arch O. Kneemiller, 34; Edward E. Remmert, 32; James E. Riley, 24.

In winning, Magee carried only one precinct, the fifth. but ran strongly in all wards and the plurality in the fifth was determining factor in the race. There gin of 408 "for" to 386 "against".

Hazel Willerding gathered 528 votes and Ted Gould got 468 to gain re-election to the school board.

Other vote totals were: David Kuhn, 336; Dorothy Moit, 286; Lorene Kettles, 51.

#### O'Fallon R-2

O'Fallon R-2 District voters passed a 20-cent school tax levy increase by a margin of only 22 votes, increasing the rate of the district to \$3.52 per \$100 assessed valuation. The vote total showed 556 votes in favor of the hike while there were 534 votes against it.

The tax rate needed only a simple majority which it just did receive.

The 20-cent increase was sought for the Teachers Fund which will provide an additional 21 teachers who will be needed in the school district next year. Continued larger enrollments in the district are almost a certainty.

Two incumbent school board members, seeking re-election, Delmar C. Emge and William D. Hancock received 937 and 925 votes respectively as they were unopposed in the balloting.

R-3 District

The R-3 School District, Weldon Spring, passed a 50-cent school tax levy increase, bringing the district's overall rate to \$3.80, second highest in the county.

Official returns showed that there were 354 voters in favor of the tax hike, compared to only 144 against.

Ten cents of this increase is earmarked to retire bonds and to pay interest on bonds.

The remaining 40 cents will be used for expansion of facilities in the district to handle increased enrollments in the schools in the next school year.

Incumbent school board members Norman Engelage and Clyde Mouser were re-elected for an-(continued on Page 2) 874 money is paid by the Federal Government to offset taxes lost to a school district because parents employed or working or Federal property represent loss in tax revenues to a school district. #### Leo Zerr Retains Office Of Mayor At Saint Peters

Incumbent Mayor Leo Zerr of St. Peters, Mo. was returned to office for another term in yesterday's annual municipal election, receiving 47 votes. He was unopposed.

City Treasurer Cyril Ell was also returned to office unopposed, garnering 45 votes.

The aldermanic post in the North Ward was won by incumbent Alphonse Koester with 12 votes while opponents George Stiefvater had 5 and Robert Schneider, 3.

Robert Kuester won a four-man race for Second Ward alderman, collecting 15 votes, while opponents were David Conoyer, 8; Joe Singleton, 3; and Cyril Heintzelman, also 3.

Incumbent alderman K. B. Mc-Gines did not seek re-election.

#### \$500 CASH AND \$200 IN STAMPS STOLEN IN WENTZ. BURGLARY

More than \$500 in cash and \$200 worth of mailing stamps were taken in a burglary at the Missouri Edison Office in Wentzville last night, the Missouri State Highway Patrol reported today.

The money and stamps were taken from two different safes, located in the office, which were peeled by the intruders.

The burglary was discovered this morning by an employee upon reporting for work. cumbent Donald J. Off was unopposed in the First Ward, being returned to office for another term, while a three-man race in the Second Ward went to incumbent Frank Grasser (33 votes) while opponents Lou Johnson received 17 and V. P. LaBanca got 15.

#### SIGN-UP EXTENSION ANNOUNCED FOR CO. A. S. C. GRAIN PROGRAM

According to Herbert Wappelhorst, Chairman of the St. Charles County Agricultural Stabilization and Conservation Committee, the Secretary of Agriculture has announced a one-week extension in the signup period for Feed, grain, wheat and cotton. This ex.ension is through April 9, 1966. Any changes in contracts will also be accepted until Friday.

The Secretary also announced an increased price support of \$2.50 per bushel for the 1966 crop of soybeans. This announcement may affect the farming plans of many producers and the extended signup period will permit them to change their plans accordingly.

An incumbent City Marshal and two incumbent aldermen were ousted in their bids for reelection yesterday in the annual city elections held in the com-munity of O'Fallon.

City Marshal Richard Wilson, after serving two two-year terms, was upended in a strong showing by Joseph S. Mayer who formerly was associated with the police department in St. John's, Mo. and currently holds the position of police chief in Charlack in St. Louis County.

Mayer, in his first bid for the office, received 433 votes while the incumbent Wilson lost by 17 votes, garnering 416 votes.

In probably what was considered the most surprising result in the aldermanic contests, Lawerence W. Huber won over veteran businessman and civic leader Russell Emge by a vote of 49 and 40 respectively in the Fourth Ward.

In the First Ward, incumbent Delbert C. Peters was defeated by Louis C. Bussinger, a former councilman. The winner received 124 while 111 were tabulated in Peters' favor.

In the Second Ward three-man race, another incumbent went by the wayside as James Cox was unseated, losing to Edward J. Griesenauer, Sr. 133 to 116. The third candidate James D. Eddleman received only 31 votes.

In the Third Ward John D. King totaled 230 votes, being the only council candidate unopposed.

#### Former Wentzville Mayor F.L. Payne **Returns To Office**

Former Wentzville mayor, Fred L. Payne was returned to that post by the voters in yesterday's elections in a three way race for the post which incumbent Mayor Guss Temme did not seek.

Payne polled 315 votes to top Frank Fraze's total of 255 and Wilfred G. Meier's 108.

In Wentzville's aldermanic contests, First Ward Incumbent Councilman Robert P. Menne was successru in his bid for reelection as he tallied 233 votes to 39 for opponent Engelbert F. Bareiter.

The second ward post, which was held by Fraze, was won by James Huellewig as he took 199 votes to Wallace Norton's total of 180.

Incumbent City Collector Mrs. Viola Boland retained her position as she beat Anthony M. Perkings 515 to 145.

Four officials who ran unopposed and were returned to office were City Marshal Samuel S. Anselm, City Treasurer Mrs. Dorothy Anselm, Police Judge Ernie Von Nida and City Assessor Kurt Mueller.



ran strongly in all wards and the plurality in the fifth was determining factor in the race. There he polled 80 votes to 30 for Buehler and 11 for Webbink.

Webbink's strength was in the first precinct where he gathered 93 votes to 49 for Buehler and 43 for Magee. In the second precinct, Webbink had 52, Magee 44, Crea-cy 41 and Buehler 11. Buehler won the fourth precinct with 81 votes as compared to 78 for Magee and 34 for Webbink.

In the regular election in the First Ward, Joseph R. Briscoe Jr. was the only opposed incumbent to win re-election as he had the sound majority of 607 to 204 for Donald Groves, his only opponent.

In the Fourth Ward, William Shea, a former First Ward councilman, will once again take a seat on the council as he piled up 257 votes to 69 for Mrs. Elsie Bailey, 61 for Henry Bodefeld and 38 for Mrs. Mary Agler.

Kenneth C. Johnson, running unopposed in the Third Ward, drew 227 votes. Lawrence Boschert, also running unopposed for the position of city attorney, had a city-wide total of 2117 votes.

In the school board elections, Stephen T. Blackhurst and Dr. James H. Evans were elected with totals of 2034 and 1742 respectively. Edward Remmert drew a total of 655 votes.
